

# SERVICE AGREEMENT

I / We, the undersigned, hereby apply to book my/our mare to be served by the above named stallion during the ..... season and confirm that I/we are the registered owners/lessee of the above named mare and accordingly have full rights to enter into this agreement on the following terms and conditions:

1. SERVICE FEE
  - 1.1 The total service fee is \$.....
  - 1.2 This service fee DOES NOT include a colour guarantee.
2. CONDITIONS OF PAYMENT
  - 2.1 A non-refundable deposit/handling fee of \$300 is payable on booking.
  - 2.2 The remainder of the service fee plus any additional charges (as indicated in clause 3 herein) are payable upon a positive pregnancy test and/or prior to the mare leaving the stud.
  - 2.3 If the service is by A.I. then the entire service fee is payable before the semen will be transported.
3. EXPENSES
  - 3.1 I/we agree to be responsible for the payment of all service fees, costs and expenses incurred by my/our mare and/or any offspring including: -
    - (a) the deposit (non-refundable)
    - (b) the service fee
    - (c) agistment costs (as designated in clause 4 herein)
    - (d) additional feeding per week (cost as advised)
    - (e) transport costs
    - (f) veterinary costs
4. AGISTMENT COSTS
  - 4.1 An agistment fee of \$.....per week is payable for paddock agistment of dry mares.
  - 4.2 An agistment fee of \$.....per week is payable for padock agistment of wet mares.
  - 4.3 Stabling and additional feed will be provided upon written request only, at a cost to be advised at the time of the written request.
5. INSURANCE
  - 5.1 I/we the mare owner acknowledge and accept that the stud has made no representation nor have we relied on any representation to the fact that any insurance against loss, injury, illness or death of the mare is held or arranged by the stud and accordingly any loss, injury, illness or death is at my/our sole risk and expense.
6. CONDITIONS OF ACCEPTANCE
  - 6.1 I/we the mare owner acknowledge that: -
    - (a) the stud reserves the right to refuse any mare for service;
    - (b) my/our mare must be tractable and handled to lead;
    - (c) should the mare refuse service or;
      - (I) constitute a danger to the stallion or its handlers; or
      - (II) is found to be unclean and/or otherwise unfit for service and, after taking veterinarian advice is rejected, another suitable mare may be substituted, however, all fees incurred
